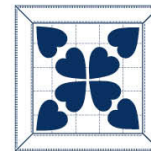

## 2017 Crafters and Food Trailers Contract

**Location:** Trinity Church, Fuel Center, 212 Pennock St., Registration for the Festival located at this building or at the Senior Citizen Center, 125 4<sup>th</sup> Ave. North.

**Description of Outdoor Space:** 10' x 10' or larger -- \$30.00 Space available on the grass.  
Food Trailers -- \$90 -- Space available at the Senior Center and on the grass at Trinity Algood

The Crafters Contract must be accompanied by check or money order and received no later than August 1. ### Terms & Conditions:

- Festival Hours are 9 a.m. – 4:00 p.m. Friday & Saturday, September 22 & 23, 2017.
- Booths must be completely set up and ready for customers when the Festival opens on Friday @ 9:00 a.m. Tear down may begin Saturday, September at 4:00 p.m. and must be completed by 6:00 p.m. Crafters MUST remove all trash in your area at tear down.
- Crafters must provide your own tent, tables/set up fixtures. Electricity will not be available.
- This is a two-day festival and Crafters must utilize their space for both days. Crafters cannot shut down prior to the close of the Festival for any reason without prior authorization from the Festival Board.
- There are no refunds after August 1 and/or once you have been accepted into the Festival.
- No one shall occupy the space other than the original contracted merchant without consent of the Festival Board.
- Each Crafter is responsible for paying his/her state sales taxes.
